#### **Amendment to the Tamil Nadu Building and other Construction Workers (Regulation of Employment and Conditions of Service) Rules, 2006.**

No. SRO A-16/2025.—In exercise of the powers conferred by section 62 of the Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 1996 (Central Act 27 of 1996) the Governor of Tamil Nadu, after consultation with the expert committee, hereby makes the following amendment to the Tamil Nadu Building and other Construction Workers (Regulation of Employment and Conditions of Service) Rules, 2006, namely:-

#### AMENDMENT.

In the said Rules, in rule 241, in sub-rule (3), after the expression, "the Contract Labour (Regulation and Abolition) Act, 1970 (Central Act 37 of 1970)," the expression "or the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Act, 1979 (Central Act 30 of 1979)" shall be inserted".

#### **Amendment to the Tamil Nadu Factories Rules**

No. SRO A-17/2025.—The following draft of an amendment to the Tamil Nadu Factories Rules, 1950, which it is proposed to be made in exercise of the powers conferred by section 112 of the Factories Act, 1948 (Central Act 63 of 1948), is hereby published for information of all persons likely to be affected thereby, as required by section 115 of the said Act.

Notice is hereby given that the following draft amendment will be taken into consideration on or after the expiry of forty-five days from the date of publication of this notification in the *Tamil Nadu Government Gazette* and that any objection or suggestion which may be received from any person with respect thereto, before the aforesaid period of expiry, will be considered by the Government of Tamil Nadu. Objection or suggestion, if any, should be addressed in duplicate to the Secretary to Government, Labour Welfare and Skill Development Department, Chennai-600 009, through the Director of Industrial Safety and Health, 47/1, Thiru.Vi.Ka. Industrial Estate, Guindy, Chennai-32.

#### DRAFT AMENDMENT

In the said Rules, in rule 4, in sub-rule (6), after the second proviso, the following proviso shall be added, namely:-

"Provided also that in case of fireworks factories, the maximum number of persons shall be fifteen percent in excess of the man limit specified in the licence granted under the Explosives Act, 1884 (Central Act 4 of 1884) and the Explosives Rules, 2008."
