Sir / Madam,

In reference to the above-mentioned letters on the subject cited above, the undersigned is directed to convey the approval of the Central Provident Fund Commissioner / President, Central Staff Welfare Committee, Employees' Provident Fund Organisation, for enhancement of the ex-gratia amount under Death Relief Fund from Rs. 8.80 Lakh to Rs. 15 Lakh. The ex-gratia amount of Rs. 15 Lakh (Rs. Fifteen Lakh only) shall be paid to the family members (nominee or legal heirs) of the deceased employee of the Central Board, from the Staff Welfare Fund.

2. The above instructions shall come into force with effect from 01.04.2025.
3. Further, this ex-gratia amount shall be increased by 5% every year starting from 01.04.2026.
